

## WARNINGS

- Fitt Force™ Pro is intended for outdoor watering applications only;
- Not for hot water use;
- Do not leave under pressure when not in use;
- Do not leave unattended children to use **Fitt Force™ Pro**:
- Do not leave out on freezing temperatures;
- Store indoors in winter;
- For proper use, allow water to flush through trough hose few minutes before drinking;
- Coupling protection: to avoid any kind of corrosion causing fusion between faucet and coupling hose, we suggest disconnecting and reconnecting the hose from any metal spigot a minimum of 3 time per year.

## LIMITED WARRANTY

The Warranty shall not cover defects of or damages to products due to erosion, corrosion or material deposits from fluids other than water.
